## Rainy Day Reminders

RSCCA members are encouraged to prepare for Rain by: inspecting roofs for leaks and making repairs before the onset of rain; inspecting and cleaning out all gutters, drains, and V-Ditches to allow for adequate flow of run-off to the storm drains; and by renewing flood insurance policies.

## Winter Water Use Limits

### Level 2 Water Alert

Dec. 1, 2016 to Feb. 28, 2017  
Irrigation is limited to one day a week.

- Even numbered Residential- Monday
- Odd-numbered Residential -Saturday
- Commercial— Thursday.

Restrictions do not apply to 5 RSCCA meters along Calle Del Cerro and lower V. Montana that use reclaimed water.



### Topping Trees

Arborists warn against cutting off the tops of trees, because chlorophyll in the leaves is used in photosynthesis to produce food and energy for trees.

The trees become temporarily starved and replace the loss of leaves by rapidly generating a plethora of thin, weak, branches.

Topping also allows pests, parasites and other harmful organisms to burrow into the trees and under the bark where colonies multiply and invade into the core of the tree.

In drought conditions, the cumulative effects can be devastating.
